1. CALL TO ORDER

Commissioner Stokes called to order the Planning Commission meeting into order on March 13, 2017 in the Commission Chambers located at City Hall, 620 E. Main Street, Haines City Florida at 4:00 p.m.

Planning Commission members in attendance were: Richard Wiley, Brian Stokes, Joe Hamilton, Dr. Earle Lee, Doris Abercombie. Absent were Louie McLean and Denna Tyler.

Staff members in attendance were: Development Services Director Richard Greenwood, Senior Planner Raymond Perez, Secretary Maricela Garcia, and Deputy City Clerk Erica Anderson.

2. APPROVAL OF MINUTES

Staff presented the Minutes from February 13, 2017 for approval.

Commissioner Stokes opened the floor for a public comments.

No members of the public came forward to speak with the Planning Commission.

Commissioner Stokes moved to approve the minutes. Commissioner Wiley seconded the motion. The motion was approved by unanimous voice call vote.

3. NEW BUSINESS

3.A. PUBLIC HEARING

An application has been submitted for a RPUD (Residential Planned Unit Development) Subdivision known as Cassidy Ridgecrest at North Blvd. Phase II, Located east of Highway 27, West of Holly Hill Road, North and South of North Boulevard West in Haines City, Fl. The project site contains 38.01 acres and 173 family home sites are proposed to be developed.

3.A.1. MOTION: MOTION TO APPROVE THE APPLICATION FOR A RPUD SUBDIVISION- CASSIDY RIDGECREST AT NORTH BLVD. PHASE II

Engineer Dennis Wood who worked on both Cassidy Phase I and II voiced specific criteria of which the county has imposed.

An application for Land Use Plan Amendment (LUPA) change from professional Office /Institutional - North Ridge (PC-NR) to Low-Density Residential - North Ridge (LDR-NR) located East of US Highway 27, West of Holly Hill Road, North and South of North Boulevard West in Haines City, Fl. The project site contains 38.01 acres.
