Subject: City Commission Compensation

Introduction

The intent of this business item is to finalize the direction from the City Commission on compensation and benefits offered to the elected officials in order to bring forward an Ordinance establishing the guidelines for implementation. According to the State of Florida Office of Economic and Demographic Research, 23,252 was the estimated population as of April 1, 2016 for the City of Haines City.

Current City Commission Compensation

Mayor \$7,200
 City Commission \$6,000

Background

At the February 16, 2017 City Commission Workshop, the City Commission provided City Staff direction to bring forward an Ordinance that would have a comparable compensation of that between the City of Lake Wales (\$12,860) and the City of Bartow (\$10,870). In addition, it was also agreed the annual increases should be based upon population.

The salary adjustment proposed equates to an approximate 5.75 % annual increase since 2002 or 87.39%. The purpose is to bring the compensation in line with similar cities of size and population.

On October 1st of each year, the City of Haines City shall obtain the State of Florida Office of Economic and Demographic Research population estimates. The annual base salary adjustments for the City Commission and Mayor shall be calculated by the population estimate comparative to the above City Population Range Chart.
